**33.** Oral notice having been given October 9, 2019, moved by Hon. Mr. Schweitzer on behalf of Hon. Mr. Nixon:

Be it resolved that the Legislative Assembly denounce the federal government's decision to reduce the rates at which it reimburses the costs of providing health care services to Canadian Armed Forces members, call on the federal government to immediately reverse this decision and provide the highest level of treatment for these members, and recognize the contribution of these members who bravely and willingly risk their lives for our country.

A debate followed.

Hon. Mr. Shandro, Minister of Health, moved that the motion be amended by striking out "call on the federal government to immediately reverse this decision and provide the highest level of treatment for these members" and substituting "call on the federal government to immediately and fully reverse this decision, commit to no future changes, and provide the highest level of treatment for these members."

A debate followed on the amendment.

The question being put, the amendment was agreed to.

Debate continued on the motion as amended.

Debate adjourned.
